Editing Evolution: The Techniques and Potential of Synthetic Biology.

Humans have directed evolution since the advent of farming, however, emerging methods in biotechnology have dramatically increased human control over the genome. This course will act as an introduction to modern bioengineering methods and real world examples of this science at work. We will cover cloning, gene sequencing, PCR and the CRISPR-Cas system before discussing the modern ethical implications of these techniques. If room scheduling allows - we would love to walk students through a wet lab protocol giving hands on experience with some of the techniques discussed.

Christopher Wren Association (CWA) Instructor Policies:

- 1. The Program Committee is responsible for making room and time slot assignments for all classes and activities. Every effort is made to honor specific requests for these assignments. However, as our program grows, spaces become more difficult to adjust. Instructors are urged to make such requests only when absolutely necessary.
- 2. The use of student email addresses is strictly limited to matters regarding the class you are teaching.
- 3. Our enrollment is on a first-come first-served basis and no student can be guaranteed entry into any class. Instructors do not have authority to permit someone to attend their class if not enrolled.
- 4. Instructor opinions as part of a course:
 - a. It is perfectly appropriate for CWA instructors to express their opinions, provided they indicate the statements are opinion. If it is a major matter, it is a good idea for the instructor to have indicated to the class, the principal contours of the intellectual controversy.
 - b. It is not appropriate for a CWA course to be wholly or even primarily about a set of opinions. The purpose of a CWA course should be to expand students' understanding of a subject matter, including different positions, not to take a position on that subject matter. In other words CWA should never become a "soap box".
- 5. Audio and video recording of CWA classes by students or instructors is not permitted.
- 6. CWA courses are not to be used as a platform to push a product. It is acceptable for an instructor to mention that he or she has written a book on the topic but the course must not become a "sales pitch". Similarly, courses should never push a specific product (insurance, real estate, financial planning, etc.).
